- Can I **balance duty of care** with the **rights of children** and **families**, particularly in situations involving **conflicts** or **dilemmas**?

- Can I list different **types of team working** and describe how teams may differ in their **structure**, **purpose**, and how they're **composed**?
- Do I know the core principles that support effective team working?
- o Can I explain how effective team working contributes to the well-being of children and their families / carers?

LO4: Know how to handle information in early years and childcare.

- Do I understand what is meant by the terms 'handling information' and 'data protection'?
- Can I identify the **legislation** and **Codes of Conduct and Professional Practice** that relate to the handling of information, including **storing**, **recording**, **confidentiality**, and **sharing**?
- Do I know what 'secure systems used for recording and storing information' are, why it is important to have them in early years and childcare settings, and the features of manual and electronic information storage systems that help ensure the security of information?
- Do I understand which **information** needs to be **recorded**, **reported**, and **stored**, and how to record this information with **accuracy**, **clarity**, **relevance**, and an appropriate level of **detail** in a timely manner?
- o Can I distinguish between **fact**, **opinion**, and **judgement** when recording information?
- Do I understand the importance of **sharing recorded information** with individuals and know **when** and **why** this **cannot occur**?

- Can I explain why it is **important not** to form **inappropriate relationships** with children, their families/carers, colleagues and others?
- Do I understand why it is important to **recognise** and use sensitively, the **power that comes from your role** in working with children, their families/carers and **not** act in any way that **abuses** this power?

LO6: Know how continuing professional development contributes to professional practice.

- Do I understand what 'Continuing Professional Development (CPD)' means and its related legislation and standards?
- Am I aware of the Welsh Language Standards and its importance?
- Can I evaluate my own knowledge, understanding and practice against relevant standards and information?
- Do I understand the responsibilities of **employers** and **workers** for **continuing professional development** and the **learning opportunities** available to them?
- Do I know how to **access** and **use information** to support my role and **apply learning** to new situations?
- Do I understand the importance of **seeking** and **learning from feedback** on practice from children, their families/carers, colleagues and others?
- Am I familiar with the concept of **'reflective practice'**, why it's **important**, and **how it's used** in **supervision** and **appraisals**?
- Can I explain the **impact** of effective **supervision**, **reflective practice**, and relevant **learning opportunities** on the **well-being** of children and their families/carers?
- Do I know where **literacy**, **numeracy** and **digital skills** are needed to support professional practice, and how to **develop** these skills?
- o Can I identify ways to develop my Welsh language skills to support children and their families/carers?
